Primarily PHMSA and USCG regulations related to pipelines, breakout tanks, and marine loading. • Develop, implement, update and evaluate compliance policies and programs to ensure full compliance. • Train and coach employees and local supervisors in Company compliance policies, programs, and procedures. • Work closely with local leadership to facilitate field compliance with established procedures and practices. • Identify and communicate safety and compliance requirements and risk to Company leadership. Recommend control measures as appropriate. • Represent the Company, as warranted, with certain stakeholders. • Prepare for and participate in scheduled and unscheduled audits and inspections by external regulatory agencies. • Conduct internal compliance audits and safety evaluations; present results to leadership. • Plan, execute, and evaluate drills as required by spill response and emergency response plans. • Track, analyze, interpret, and present compliance performance data to employees and leadership on a regular basis. • Prepare and submit timely regulatory reports and documentation as required by regulatory agencies. Maintain current, accurate, and complete records. • Participate in incident investigations and workplace assessments.
