### **General Summary**

The Operator 1 is an entry level training position that requires assistance in the pipeline dock and terminal activities. These training tasks will allow the Operator 1 to assist in conducting daily routine terminal operations and high stressed environments caused by emergency situations. The Operator 1 will train in the pipeline, tank farm operation and docks while becoming familiar with the facility and its' basic functions. The Operator 1 will learn how Pin Oak and their customers interacts and communicates with each other. This knowledge will allow the Operator 1 to become familiar with the overall facility, associated activities, and daily tasks. The Operator 1, once certified is expected to step up and cover for the Operator 2 as needed.

### **Essential Functions**

- Attend scheduled safety meetings as required
- Perform responsibilities as team member, carrying out all daily tasks from Operations Manager, and acting as key team member for compliance of all terminal operational, safety and environmental procedures
- Follow all routine procedures, verbal and/or written tasks, emergency procedures and Facility Response Plan (FRP)
- Participate in identifying non-compliance of environmental regulations so that proper notification to agencies may be executed
- Contribute in troubleshooting terminal operational and mechanical problems as experience is acquired
- Follow all safety policies and procedures when assisting in preparing equipment for maintenance
- Perform preventative maintenance as required
- Complete all Health Safety Environment, Operator Qualification, and procedural training required for position

- Demonstrate excellent mechanical aptitude and troubleshooting skills
- Assist in removing and returning process and terminal equipment from/to service

### **Main Tasks**

- Responsible for becoming proficient in safe and reliable operation of the pipeline, tank farm, truck rack and marine operations
- Responsible for assisting in the gauging of each tank as required, tank line ups and transfers
- Be proficient in maintaining all product streams to the designated storage tank
- Assist in lineups regarding tank storage and transfers
- Be proficient in all documentation of routine and non-routine events that occur during the shift
- Participates in all Job Safety Analysis
- Assist in preparing all equipment for maintenance prior to any work activities beginning
- Work with the team in performing product transfer operations: shipments (via pipeline, barge, truck, and railcar) and receipts (via pipeline, barge, truck, and railcar)
- Dock watch duties as needed
- Train on performing tank gauging using approved methods and safety practices, witness and record gauges by representatives of independent inspection services
- Learn to sample tanks as directed using proper technique, equipment, and safety procedures
- Become able to respond in reasonable time to abnormal operating conditions
- Maintain all terminal areas in the cleanest possible conditions
- Conduct routine inspection rounds of terminal area
- Monitor pumps for abnormal sounds, leaks and proper lubrication
- Expand knowledge of the Operator 2 position and position self to cover the Operator 2 position as needed
- Participate in Tool Box Safety Meetings on first day/night of shift

### **Competencies, Education, Knowledge, Skills and Abilities**

- No immediate experience necessary as Pin Oak will provide training
- Process Technology degree preferred
- High School Diploma/GED required
- Capable of developing understanding of terminal functions
- Must be able to work 12-hour rotating shift and potential overtime
- Must be able to read, write, and speak in the English language

### **Physical Demands**
